I just returned from beautiful Panama City, Panama (which you can see over my shoulder), where I had the tremendous privilege of facilitating training of school owners. This truly amazing group of educational leaders represent schools and school systems located in **Colombia, Costa Rica, Dominican Republic, Ecuador, Honduras, Nicaragua**, and Fayetteville, North Carolina (me).

The conference was sponsored and coordinated by the *Global School Consulting Group (GSCG)*, with which I hold an honorary title of "Executive Consultant" (due to the voluntary contributions I am able to make to GSCG—thanks to your support).
